



# LIMITED POWER OF ATTORNEY

## DEFINITIONS

“the Appointee” means the money manager who has been authorized with power of attorney on the Client’s trading account with MAPS IG.

“the Client” means the individual or entity who opened an account with MAPS IG

“the Client Agreement” means the signed documentation required by MAPS IG of its Clients and named as such, which may be amended at MAPS IG’ sole discretion .

## TERMS OF AGREEMENT

I hereby confirm that:-

- (i) The Appointee is authorized by me to have complete authority to conduct trades on my behalf with MAPS IG in respect of the above account(s);
- (ii) The Appointee is authorized by me to have complete authority to place, amend or remove orders on my behalf with MAPS IG in respect of the above account(s);
- (iii) The Appointee is authorized by me to have complete authority to pass and receive information on my behalf to MAPS IG in respect of the above account(s);
- (iv) I place no restrictions in respect of the clauses above;
- (v) I shall be responsible for all actions taken by the Appointee in respect of the conduct of my account(s) with MAPS IG;
- (vi) MAPS IG may accept all and any instructions given by the Appointee as if they were given by me and shall not be responsible for any acts or omissions on their part;
- (vii) I fully understand that MAPS IG are not making a representation either express or implied that they endorse the Appointee’s activities or abilities in relation to trading;
- (viii) I understand and accept that the conduct of my account remains my full responsibility and my obligations under my Client Agreement with MAPS IG are not diminished in any way by my signing of this Power of Attorney such that, any instructions given by the Appointee may fully be deemed to have been given by me directly or any abuse of the services provided by MAPS IG, by my Appointee, will remain my responsibility;



# LIMITED POWER OF ATTORNEY

- (ix) I understand that the appointment made under this Power of Attorney and its contents shall be part of my Client Agreement with MAPS IG and that the Client Agreement permits MAPS IG to reject any instruction or request given by any appointee if, in their sole discretion, they have reasonable cause to believe such rejection to be appropriate;
- (x) I fully indemnify MAPS IG against any act or omission on the part of my Appointee;
- (xi) I undertake to provide written notice to MAPS IG of any intention to terminate any appointment made under this or any other Power of Attorney and that such notice may not be deemed to have been received and acted upon by MAPS IG unless and until I have received written confirmation from them;
- (xii) This Power of Attorney shall be subject to the same legal jurisdictions and thresholds as stated in the MAPS IG' Client Agreement.

Please note that the Appointee may receive transaction based compensation from MAPS IG in the form of rebates or, furthermore, commissions where these have been agreed by you. The receipt of which constitutes a conflict of interest as it may create an incentive for the Appointee to trade the account more frequently in order to generate additional revenue.
